



- Filter vessel is available in carbon or stainless steel with elastomer seal options of Buna-N, EPDM, or Viton.
- Double diaphragm pump is powered by compressed air. No electric power needed.
- Eaton Model 30R Strainer with a 1/8" perforated basket pre-filters incoming contaminated fluids on the carbon steel model, and the Model 72 Strainer pre-filters fluids on the stainless steel version.
- The filter vessel includes 1-1/2" inlet and outlet hoses, extension wands, and pressure gauge.
